

EUSKADI



1) MAIN PRIORITIES

The Department of Culture and Linguistic Policy of the Basque Government offers financial support for the script, project development, production and coproduction of Basque films.

Supports the exhibitors and promotion of the films through Zineuskadi association and films heritage with the Basque Archive (Euskadi Filmategia).

Furthermore, represents Basque films abroad under the Basque Audiovisual umbrella thanks to the coordination between Etxepare Basque Institute, Eiken Audiovisual Cluster and Zineuskadi.

2) TAX REBATES FOR FOREIGN FILMS AND TV SERIES

DEDUCTION PERCENTAGE

Araba: 25%

Bizkaia: 20%

Gipuzkoa: 25%

DEDUCTION BASE

1. Expenses for creative staff (tax residence in Spain or in another European Union Member State) limited to €50,000 per person.
2. Expenses relating to technical industries and other supplies.

REQUIREMENTS AND LIMITS

- The money spent in Spanish territory amount must be at least 1 million euros (2 million in Alava).
- May not exceed 2,5 million euros per production carried out.
- The amount of this deduction, together with the other aid received by the taxpayer, may not exceed the production cost.

TIMING

- The right to request the Tax Rebate belongs to the Line Service. The timing for this request is the following fiscal year to the year of shooting. That is, when the Line Service fulfill the company income tax applications form, (July).
- The refund of the Tax Rebate should be within the next six months after the submission of the company income tax application form. If there is a delay, financial interest will accrue.
- Tax Rebate could be financed by a Spanish Bank.

3) TAX CREDIT FOR SPANISH PRODUCTIONS AND INTERNATIONAL COPRODUCTIONS

DEDUCTION PERCENTAGE

Araba: 30%*40% (if the film is in Euskara).

Bizkaia: 30%.

Gipuzkoa: 30%*40% (if the film is in Euskara).

DEDUCTION BASE

Total production + prints + marketing costs expend by the producer.

REQUIREMENTS & LIMITS

- Application of deduction without quota limit in Bizkaia. In Araba and Gipuzkoa*, the amount of this deduction may not exceed 2.5 million euros. The amount of the deduction, together with the other aid received, may not exceed 50% of the production cost.
- The amount of the deduction, together with the other aid received, may not exceed 50% of the production cost.
- Coproductions: The amounts indicated in this section are determined for each coproducer according to their

respective percentage of participation in each production.

- Producers must be registered with the REC (Registro de Empresas Cinematográficas or Registry of Filmmaking Companies) of the Ministry of Education, Culture and Sport.
- 40% on those productions in Basque as original language and, at least, 50% of the deduction base will correspond to expenses incurred in the Territory of Araba and Gipuzkoa.



NAVARRA



1) MAIN PRIORITIES

Each year, the Government of Navarre's Department for Culture and Sport awards Generazinema grants, through which it subsidises development, production and promotion projects for films which qualify as Navarre-based films, and supports cinemas located in Navarre and festivals organised in the community. The department also carries out actions to protect Navarre's cinematic heritage through the Archive of the Navarre Film Library (Filmoteca de Navarra).

It manages the programmes of the Navarre Film Library, the Navarra Film Commission and the Punto de Vista documentary film festival through the public enterprise NICDO.

2) TAX REBATES AND TAX CREDIT FOR FOREIGN FILMS AND TV SERIES

Tax credit for investments in the production of feature-length films and audiovisual series in the categories of fiction, animation and documentary (Regional Law 26/2016 on corporation tax in Navarre, Article 65).

Beneficiaries:

- Production or co-production companies involved in Spanish productions of feature-length films and audiovisual series in the categories of fiction, animation and documentary (Article 65.1).

- Production companies responsible for the execution of the production of Spanish and international feature-length films and audiovisual works (Article 65.2).
- Payers of Corporation tax or Non-resident income tax that participate in the funding of Spanish productions of feature-length films and audiovisual series in the categories of fiction, animation and documentary (article 65 bis).
- Productions directed by a person who has not directed or co-directed a feature-length film or audiovisual series in the categories of fiction, animation and documentary.

ARTICLE 65.1

Scope of application:

Investment in the production of Spanish film and television series (fiction, animation or documentary).

Percentage of overall tax credit: 35% of deductible expenditure.

Percentage of special tax credit: 40% of deductible expenditure (with respect to the first million of the basis of deduction), in the following cases:

- Productions whose sole original version is in the Basque language.
- Productions made exclusively by women directors.
- Documentary productions.
- Animation productions.

Basis of deduction: Production costs; advertising, promotion, adaptation and print expenditure.

Conditions and limits:

- More than 40% of expenditure incurred in Navarrese territory.
- Maximum amount of the deduction: 5 million euros.
- Certificate of nationality and cultural qualification, issued by the ICAA (Spanish Institute of Film and the Audiovisual Arts).
- Prior report and later validation by the Directorate General for Culture of the Government of Navarre.

ARTICLE 65.2

Scope of application: Services for the production of Spanish and international feature-length films or audiovisual works.

Percentage of tax credit: 35% of expenditure incurred in Navarrese territory.

Basis of deduction: The expenditure incurred in Navarrese territory directly related to the production concerning:

- Expenditure on creative staff, provided their tax residence is in Spain or in any member State of the European Economic Area, to a limit of 50,000 euros per person.
- Expenditure derived from the use of technical industries and other suppliers, and the transportation, accommodation and living expenses necessary for production.

Conditions and limits:

- Minimum of one week of shooting interiors or exteriors in Navarre.
- The basis of deduction must not exceed 80 per 100 of the total cost of production.
- Maximum amount of the deduction: 5 million euros.
- Deduction does not apply when the producer receiving the services applies the deduction established in Article 65.1.

ARTICLE 65 BIS

Scope of application:

Taxpayers who participate in funding Spanish productions of feature-length cinema films and audiovisual series in the categories of fiction, animation and documentary made by other taxpayers entitled to the right to the deduction established in Article 65.1.

Deduction: A maximum, in terms of quota, of the result

of multiplying the amounts disbursed by 1.25.

Conditions and limits:

- Not applicable when the taxpayer is involved with the production company.
- A funding agreement signed between the production company and the taxpayer participating in the funding of the production prior to completion of the tax period in which the deduction is generated.
- The taxpayers may not acquire intellectual property rights or rights of any other nature regarding the results of production.
- The production company is not entitled to application of the deductions provided for in Article 65.1.

3) MAIN LINES OF REGIONAL AUDIOVISUAL SUPPORT

Generazinema Development:

Grants for the development of cinema film and audiovisual work projects in the categories of fiction, documentary or animation. Individual projects or series carried out between 01/01/2021 and 31/10/2022.

Generazinema Production:

Grants for the production of cinema films and audiovisual works, both feature-length and short, currently in the project phase (fiction, documentary,

animation). Individual projects or series carried out between 01/01/2021 and 31/10/2022.

Generazinema Promotion:

Grants for participation in fairs and festivals or actions to promote or disseminate Navarrese professional audiovisual industry films between 01/11/2020 and 31/10/2021.

Generazinema Festivals:

Grants for the organisation of film festivals and competitions held in Navarre, on-site or online, between 01/11/2020 and 31/10/2021.

Generazinema Exhibition:

Grants for private and privately managed cinemas for film programmes, both general and of special interest, between 01/10/2020 and 30/09/2021.

4) MOBILITY FUNDS

Grants for participation in fairs and festivals: Accommodation expenses, daily allowances and travel expenses, accreditation or registration fees, etc.

Maximum: €3,000 per applicant.

5) APPLICATION TIMETABLE

Generazinema Development, Production, Festivals and Exhibition: Second quarter of the year.

Generazinema Promotion: April-October.

NOUVELLE AQUITAINE



NOUVELLE-AQUITAINE

1) MAIN PRIORITIES

Alca, the cultural agency for publishing and cinema in the Nouvelle-Aquitaine Region, provides a wide-range of support services for cinema and Tv Industries. It supports creation and production of fiction, animation and documentary films through fundings, artists-in-residence programs, partnerships with Labs and international markets and a regional film commission.

It also stands by film professionals from the region for national and international film festivals, coproduction events and it supports distribution and promotion.

The Nouvelle-Aquitaine Region manages a 7M€ film fund, which reaches 11M€ with 6 Local Governments' added financial support.

2) TAX REBATES FOR FOREIGN FILMS AND TV SERIES

TAX REBATES FOR INTERNATIONAL PRODUCTION

- **Tax rebate rate:** 30% (40% for VFX-intensive projects).

- **Minimum spend:**
€250,000.

- **Rebate cap per project:**
€30 million (\$34 million).
- No annual cap.
- Provisional agreement within 3 weeks.
- **VFX-RELATED BONUS:**
This 10% bonus applies to projects with more than €2M of VFX-related French expenditure. Once the €2M threshold is passed, the 40% tax rebate applies on all of a project's eligible spends, including live action spends which are not VFX-related

The TRIP supports non-French projects that are completely or partly made in France.

The foreign producer needs to contract with a French company to handle the shoot in France or/and the making of the animation / VFX shots via a production service agreement.

NB: The TRIP is exclusively targeting non-French productions. So you'll have to choose: either the project becomes French - via a co-production treaty and the CNC - or the project gets the TRIP.

3) MAIN LINES OF REGIONAL SUPPORT FOR CINEMA AND AUDIOVISUAL

NOUVELLE-AQUITAINE GOVERNEMENT MAIN SUPPORTS

Film fund managed by ALCA:

- The Film fund is active in all fields (documentary, fiction, animation) and at every step of the creation process.
- It Supports Cinema (feature film, short film, documentary, animation) and audiovisual programs (fiction, documentary, animation).



- The amount of the subsidy depends on the film's production stage: scriptwriting, development, production.
- Subsidies at every stage of the creation process can be added to one another for a same project.
- A local governmental fund can also be added to the Regional one.
- International coproductions can access the fund through a production partner established in the region. Around twenty production companies are involved in international coproductions in all fields.

Other funds managed by the department of culture of the Nouvelle-Aquitaine région:

- Program support for structures.
- Program support for companies.
- Post production support.
- Feature Film Innovation Fund.
- "Contracts of objectives and means" with regional television channels (Department for Digital development).

4) MOBILITY FUNDS

Alca local supports:

- Supports for markets and delegations for producers to participate in international markets. (accreditation, travelling and accommodation expenses)
- Support for International residencies.

5) DEADLINES

Film Fund:

- 3 different deadlines in January, September and April for short films; documentaries, feature films and animated films.
- 4 different deadlines in September, January, March and May for TV fiction.
